

**MINUTES OF MEETING OF TOWN COUNCIL
TOWN OF BREMEN, INDIANA
September 27, 2021**

The Town Council of the Town of Bremen, Indiana, met in regular session at 4:30 p.m. on Monday, September 27, 2021, at the Bremen Town Hall pursuant to notice previously published. Council members James Leeper, Mike Leman and William Daily were present. Also present were Trend Weldy, Director of Operations; Jay Stoneburner, Superintendent of the Electric Department; Alex Mikel, Superintendent of the Water Department; Chief Brad Kile, Police Department; Austin Langdon, Superintendent of the Street Department; Matt Cunningham, Superintendent of the Wastewater Department; Brian Main, Superintendent of the Park Department; Janet Anglemyer, Clerk-Treasurer; and Anthony Wagner, Town Attorney.

MINUTES: Mr. Daily made a motion to approve the minutes of the September 13, 2021 meeting, which was seconded by Mr. Leman and carried by a vote of 3 ayes, 0 nays.

CLERK-TREASURER: Ms. Anglemyer submitted the docket of claims without amendment; Mr. Leman made a motion to approve the docket as submitted, which was seconded Mr. Daily and carried by a vote of 3 ayes, 0 nays. Ms. Anglemyer then asked the Council to approve Ordinance 13-2021, regarding the 2022 budget on third reading. Mr. Leman made a motion to approve Ordinance 13-2021 on third reading, which was seconded by Mr. Daily and carried by a vote of 3 ayes, 0 nays. Ms. Anglemyer also presented Ordinance 14-2021, for changes to the yard sprinkler metering billing process, for second and third reading. Mr. Leman made a motion to approve Ordinance 14-2021 on second and third reading, which was seconded by Mr. Daily and carried by a vote of 3 ayes, 0 nays. Ms. Anglemyer noted that the State Board of Accounts audit had been completed earlier that day.

TOWN ATTORNEY: Mr. Wagner and Mr. Weldy presented Resolution 2021-18, regarding the approval of an updated American Disability Act Compliance Plan. The Council discussed the updated plan with Mr. Weldy and Mr. Wagner. Mr. Leman made a motion to approve Resolution 2021-18, which was seconded by Mr. Daily and carried by a vote of 3 ayes, 0 nays.

PUBLIC COMMENTS: Anna Salazar appeared before the Council and asked about a table that appeared in front of her restaurant. Mr. Weldy explained that he did not know where the table had come from but that the Town had not placed it here, and that as far as he was concerned she do with it whatever she liked.

DIRECTOR OF OPERATIONS: Mr. Weldy told the Council that the Oktoberfest event had gone well at the park location. He also told the Council that the school would be running a manufacturing day that would allow students to circulate through local businesses as well as several Town Departments to see how they operate on October 13, 2021. He also reminded the Council to change the next regular meeting date to October 12, to account for Columbus Day.

DEPARTMENT HEAD REPORTS:

Mr. Stoneburner had no new information to report on behalf of the Electric Department.

Mr. Mikel had no new information to report on behalf of the Water Department.

Chief Kile asked the Council to set the Trick-Or-Treat times for the Town, and the Council selected Saturday, October 30, 2021 from 5-7 p.m. Chief Kile then asked for permission to close the 600 block of East Maple Street from Thursday, September 30

through Saturday, October 2 for an auction. Mr. Leman made a motion to approve the street closure, which was seconded by Mr. Daily and carried by a vote of 3 ayes, 0 nays. Chief Kile requested permission to promote Pedro Lopez to first-class patrolman effective September 27, 2021; Mr. Daily made a motion to promote Officer Lopez to first-class patrolman effective September 27, 2021, which was seconded by Mr. Leman and carried by a vote of 3 ayes, 0 nays.

Mr. Langdon had no new information to report on behalf of the Street Department.

Mr. Cunningham had no new information to report on behalf of the Wastewater Department.

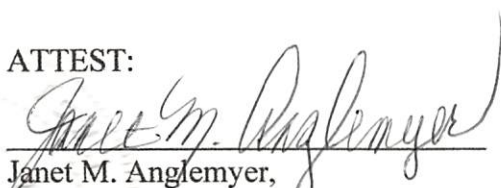
Mr. Main told the Council that the park would be entering into the annual Holy Walk lease shortly, but the dates had not yet been selected.

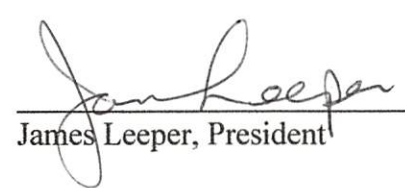
