

**ORDINANCE NO. 8-2021**

**AN ORDINANCE AMENDING THE SCHEDULE OF  
RATES AND CHARGES COLLECTED FROM THE  
USERS OF THE MUNICIPAL WATER SYSTEM.**

**(AMENDING CHAPTER 104.03 OF THE BREMEN TOWN CODE)**

WHEREAS, the Town Council now finds that the existing rates and charges for the use of service rendered by the Waterworks of said Town are too low and are insufficient to enable to Town to cover costs of operation and maintenance, provide for debt service, depreciation and capital improvements, and to maintain adequate fund balances; and that the existing rates and charges should be increased.

**NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF BREMEN, INDIANA:**

**Section 1.** That the Schedule provided for in Section 104.03 of Chapter 104 of the Bremen Town Code providing for rates and charges should be amended as follows:

**Tap Fees:**

The charge for a 1" service tap shall be in the amount of \$1,300. The charge for taps larger than 1" shall be based on actual cost of the labor, materials and supplies incurred, but in no event shall the fee be less than \$1,300.

Cost per additional meter set – \$400.

**After Hours Service Charge (non-emergency only):**

After hours and Saturdays – \$70.00 minimum for first two hours.

After two hours an additional \$35.00 per hour per employee.

Sundays and Holidays – \$90.00 minimum for first two hours.

After two hours an additional \$45.00 per hour per employee.

**Section 2.** The invalidity of any section, clause, sentence, or provision of this Ordinance shall not affect the validity of any other part of this Ordinance which can be given effect without such valid part or parts.

**Section 3.** The rates and charges as herein set forth shall become effective after the adoption of this Ordinance and its publication as provided by law.


